Each Supplier is required to fill out a Transportation Request Form for each shipment. If the shipment runs on a weekly schedule a member of our team will advise if the supplier no longer needs to complete a full Transportation Request Form. LTL, FTL, and Expedite shipments must be completely filled out with the following information:

- Complete Pickup and Delivery Location Information.
- Shipment Pieces/Pallets, Weight, Dimensions, Mode, Hazardous Permit, Stackability
- Notes / Special Instructions (If Needed)
- PTA # and Reason Code (Only Needed for Expedite Shipments)

Defining what is an LTL freight shipment

LTL shipments are defined as any shipment in excess of 4 cartons and greater than 100lbs

Carter LTL Freight Capabilities:

- From 100 lbs up to 12,000 lbs per shipment
- Up to 12 ft long (longer pieces can be accommodated, please call the contact personnel)
- Take up to 20 ft of the trailer

Truck Load Shipments

For the purposes of this routing instruction a Truckload is defined as any shipment in excess of 12,000lbs and/or exceeds 50% of the loadable space in a standard 53' dry van trailer.

All shipments delivering to EXL **MUST** have BOL, Commercial Invoice, and Packing List attached to shipment and emailed to STANTSHIPMENTS@EXL.COM.MX
